

The Management Board:

Is the Agency's planning an monitoring authority. It is composed of representatives of the EU Member States and Associate Countries, the European Commission and a representative of UNHCR.

The Executive Director:

The Executive Director, José Carreira, has been appointed by the Management Board in 2016, and is in charge of the day-to-day management of the agency.

The Executive Director is supported by 3 Departments namely:

- Department of Asylum Support;
- 2. Department of Operations;
- 3. Department of Administration.

- information and analysis support: sharing and merging information and data;
- third-country (i.e. non-member country)
 support: supporting the external dimension of the Common European Asylum System;

EPS is developed by EASO starting 2012


AIM: To provide EU+ countries and EU Institution with accurate, timely and complete monitoring of the practical functioning of the Common European Asylum System (CEAS) via a timely operational data collection and rapid analysis.


Refers to information on countries from which asylum seekers originate, relevant for the decision-makers in the field of asylum.


COI can play a determining role in achieving the aim of the CEAS: similar cases should receive similar outcomes across the EU.



TRAINING

The cornerstone of EASO training activities is the EASO Training Curriculum, a common vocational training system designed mainly for case officers and other asylum officials throughout the EU.

EASO SUPPORT IN THE HOTSPOTS. HOW DOES IT WORK?

EASO concludes **HOTSPOT OPERATING PLANS** with the host MS.

These plans aim at initiating, promoting and facilitating the EU MS synchronized efforts to support the registration and further processing of applications for international protection in the operational Host MS, where EASO Asylum Support Teams' activities will take place.

The Host MS Authorities are responsible for all asylum-related operational activities in the defined operational areas, including registration of applications for international protection, examination and decision taken in the asylum files.

EASO ensures the coordination between the participating experts in the Asylum Support Teams and technical means deployed by the Agency in the framework of EASO "Hotspot" Operating Plan.

















EASO SUPPORT IN THE HOTSPOTS. WHAT EASO DOES?

EASO staff and EASO deployed experts:

- Provide information at the disembarkation points
- Check for document fraud
- Registration of the applications for international protection
- In Greece Conduct eligibility and admissibility procedure

EASO ACTIVITIES IN GREECE

9 locations: EASO is present in Greece in Hotspots: Lesvos, Chios, Leros, Samos, Kos, and in Athens, Thessaloniki, Alexandroupoli, Corinth

Since 2015, EASO provides support to Greece, in the context of Hotspot approach and relocation, by performing a number of tasks:

- Identification of potential applicants for international protection and active information provision about the international protection system in Greece and the relocation procedure in general;
- in addition, advice on nationality assessment and possible exclusion issues to caseworkers registering relocation candidates;
- Processing outgoing Dublin take charge requests, including relocation cases;
- Detection of possible document fraud.

EASO and the EU-TR Statement

- Besides, EASO' work on relocation, EASO teams in the hotspots work on the operational implementation of the EU-Turkey Statement;
- Since March 2016, EASO has been supporting the Greek Asylum Service with regard to the Greek eligibility and admissibility procedures;
- To this end, EASO has deployed experts who conduct interviews to ensure systematic individual assessment of the admissibility of each application for international protection in Greece.



EASO PRESENCE IN GREECE

More than 200 EASO staff deployed in 9 locations in Greece

EASO and Relocation:

EASO is deploying 57 staff working in the framework of relocation in Greece:

- 23 National experts
- 27 Interpreters
- 7 EASO staff

EASO and the EU-TR Statement:;

EASO is deploying 156 staff:

- 51 National experts
- 74 Interpreters
- 31 EASO staff (of which 20 registration officers seconded to Greek AS)



EASO ACTIVITIES IN ITALY:

13 LOCATIONS: Hotspots: Lampedusa, Pozzallo, Trapani,
Taranto and in Catania EURTF, Villa Sikania,
Questura of Rome, Bari, crotone, Mineo,
Sicily Mobile Team, Rome Mobile Team

EASO supports Italy with the provision of technical and operational assistance since 2013.

Operational support to Italy in the context of hotspots and relocation was launched since mid-September 2015

EASO experts in Italy provide operational support in the following main areas:

- Provision of relevant information to potential applicants for relocation of eligible nationalities. Those activities are conducted in all operational hotspots in Italy;
- Moreover, EASO Mobile teams for information provision are deployed in Rome and in Catania to swiftly cover relevant locations and points of disembarkation;
- Handling registrations of applicants for international protection, in view of the relocation procedure, in a number of regional hubs and by a roving team;
- Handling outgoing Dublin take charge requests for relocation cases. Those activities are conducted in the Dublin Unit in Rome.




EASO PRESENCE IN ITALY:

EASO is deploying 81 staff in 13 locations + in the roving team (short-term deployment):

- 48 National experts
- 27 Interpreters
- 6 EASO staff

IPA II Programme

- Title of the project: Regional support to protection-sensitive migration management in the Western Balkans and Turkey
- Geographical coverage: Albania, Bosnia and Herzegovina, Serbia, Former Yugoslav Republic of Macedonia, Montenegro, Kosovo* and Turkey
- **Duration of the project and planned start date:** Three years: 1 January 2016- 31 December 2018
- Total budget: 8,25 MEUR
- Implementing organisation and participating organisations/ Member States: Frontex and IOM are the beneficiary of the contracts (two contracts); EASO implements activities with EU Member States (MS) and Associated Countries (AC), in cooperation with Frontex, UNHCR and IOM
- **Target group:** National authorities with operational responsibilities on matters related to asylum and/or international protection of refugees and asylum seekers.

New Partnership Framework with Third Countries under the EU Agenda on Migration

- Communication from COM, 7 June 2016
- Partnerships with TC to take the form of tailored 'compacts' according to the situation and needs of each partner
- First : Jordan & Lebanon; Then : Niger, Nigeria, Senegal, Mali & Ethiopia; Later : Tunisia & Libya
- Objectives :
 - EU can achieve greater results by speaking with one voice (rather than having differents MS acting in parallel)
 - To save lives in the Mediterranean Sea;
 - To enable migrants & refugees to stay close to home and avoid taking dangerous journeys
 - To increase the rate of returns to countries of origin & transit

• Actions :

- To improve the legislative and institutional framework for migration
- Concrete assistance for Capacity Building on Border & Migration Mangement, including providing Protection for Refugees
- Stemming the irregular flows while offering Legal Migration Channels, including increased Resettlement efforts
- Increasing rates of Return and Readmission with a preference to Voluntary return and a focus on reintegration
- EASO can work on Capacity building of National Administrations which play a role in Internal Protection

THE FUTURE OF EASO

Discussions on a European Union Asylum Agency (EUAA) with an enhanced mandate and considerably expanded tasks.

Main tasks of EUAA:

- ensure a greater convergence in the assessment of applications for international protection across the Union;
- enhanced information exchange on asylum;
- develop and provide training;
- monitor and assess the implementation of the CEAS



The European Union Agency for Asylum (EUAA)

- Strengthening the mandate of the European Asylum Support Office
- Building upon the existing mandate of EASO while transforming it into a fully-fledged Agency
- Considerably expanding the tasks to address any structural weaknesses in the application of the EU's asylum system
- Providing the Agency with its own resources and the means to become
 a centre of expertise in the field of asylum

Expanding the tasks of the Agency

- Monitor and assess the implementation of the CEAS;
- Provide increased operational and technical assistance to Member States for the management of the asylum and reception systems, in particular in cases of disproportionate pressure.
- Enhance the practical cooperation and information exchange on asylum;
- Promote Union law and operational standards to ensure uniform application of the legal framework on asylum;
- Ensure greater convergence in the assessment of protection needs across the Union;
- The revised EASO Regulation tasks the Agency to monitor and assess all aspects of the CEAS
- The role of the Agency in operational and technical assistance will be significantly expanded
